## Ph.D. Admissions 2025 - 2026 (Autumn Semester)

Applications are invited from eligible Indian nationals for admission to the Doctor of Philosophy (Ph.D.) programme in the Autumn Semester, 2025 - 2026. This programme will be offered in Computer Science and Engineering (CSE), Electronics and Communication Engineering (ECE), Mathematics and Physics. Admissions are offered in the following categories:

### **i) Research Fellow under (NET/INSPIRE/TA, etc.) Fellowship:**

**No. of vacancy:** Unreserved: 115, SC: 41, ST: 20, OBC: 75, EWS: 27 (Total: 278)

- Fellow with confirmed fellowship (NET/INSPIRE, etc.):** A student with confirmed fellowship from any recognized funding agency may apply in this category. The student has to devote **full-time** in research and help in the teaching process of the Institute.
- Institute Teaching Assistantship:** A student without any fellowship, may apply for Teaching Assistantship (TA) @25,000/- per month which may be available for a period of a maximum of 05 years. All the students in this category is required to provide service of atleast 06 hours per week as teaching assistant in theory and/or laboratory courses.

### **ii) Research fellow under Visvesvaraya Fellowship:**

**No. of vacancy:** Unreserved: 03

Students with B.E./B.Tech and M.E./M.Tech in CSE/ECE/allied disciplines may apply in this category. Fellowship will be awarded to **03 students (02 for ESDM/IT-ITES domain and 01 for C2S research domain\*)** for 05 years as per Visvesvaraya fellowship Phase II norms (1<sup>st</sup> and 2<sup>nd</sup> year: fellowship of Rs. 38,750/- per month, 3<sup>rd</sup>, 4<sup>th</sup>, 5<sup>th</sup> year: Rs. 43,750/- per month with HRA and research contingency as per norms). \*Electronics System Design and Manufacturing (ESDM), IT/IT Enabled Services (IT/ITES), Chip to Startup (C2S).

**iii) Sponsored:** A student may be sponsored by a recognized R&D organization, academic institution, government organization or industry for doing research in the Institute on a **full-time** basis. He/she must be a regular employee of the sponsoring organization with at least two years of professional experience in the respective field.

**iv) External:** A student should be employed in an R&D organization/academic institution of national repute/industry having adequate research facilities. The research work leading to the Ph.D. degree may be carried out largely in the parent organization of the candidate under a Local Supervisor from the organization but with the overall guidance provided by a faculty member (Institute Supervisor) of the Department/Centre in which he/she is registered. Such a candidate will have to complete the course work and other requirements of the Institute and will have to take official withdrawal after completion of the requirements to continue work in his/her parent organization.

**v) Part-time:** A student be a professionally employed person who pursues the Ph.D. programme while continuing the duties of his/her service. He/she must be a regular employee of a reputed organization with at least **two years** of professional experience in the respective field.

**vi) Project Staff:** A student should be working on a sponsored project at IIIT Kalyani. The remaining duration of the project at the time of admission should be at least one year.

**ELIGIBILITY CRITERIA:** For admission to the Ph.D. Programme in other categories (other than Visvesvaraya Fellowship) a candidate must satisfy the following criteria:

**For Engineering Disciplines:** One of the following criteria be satisfied:

1. Master's degree in Engineering/Technology in a relevant area (in accordance with the research domains mentioned above) with a minimum CGPA of 6.5 (in a 10 grade point scale) or 60% of marks.
2. Bachelor's degree in Engineering/Technology in a relevant area (in accordance with the research domains mentioned above) with a minimum CGPA of 7.5 (in a 10 grade point scale) or 70 % of marks. The candidate should be GATE/NET qualified.

**For Science Disciplines:**

Master's degree in Science in a relevant area with a minimum CGPA of 6.5 (in a 10 grade point scale) or 60% of marks. The candidate should be GATE/NET qualified.

Mere fulfilment of eligibility criteria does not ensure an applicant's right to admission in the Ph.D. programme. The decision of the selection committee will be final in this regard. Reservations will be applicable as per MoE, Govt. of India norms.
