At the outset Additional Secretary, MHRD on behalf of Chairman, Governing Body welcomed the members present and requested Professor P. P Chakrabarti, Mentor Director IIIT, Kalyani and Director IIT, Kharagpur to brief the members the present situation of IIIT, Kalyani.

Professor Chakrabarti, Mentor Director IIIT Kalyani introduced invited members from IIIT Kalyani and explained the current situation of the Institute. The agenda was taken up and the following resolutions were taken:

Item No. 1: Confirmation of minutes of the 7th Meeting of the Governing Body of the Institute held on 31st January, 2019.

Resolution:

Mentor Director informed that no comments were received from the partners on the minutes of 7th Governing Body meeting. The minutes of the 7th meeting of the Governing Body of Society of IIIT Kalyani held on 31st January, 2019 as approved by MHRD vide letter No. F.No.58-1/2014-TS.I dated 14th February, 2019 received by email was confirmed. Actions taken were discussed and ratified.

Item No. 2: Action Taken Report on the resolution of the 7th meeting of the Governing Body held on 31st January, 2019.

Resolution:

- a) The suggestions made by Governing Body on the situation that had raised out of class boycott by 1st and 2nd year students of IIIT Kalyani during January 2019 have been taken care of by the Institute.
- b) Advertisement has been published in the newspaper and Institute website in the first phase of recruitment to the post of the following faculty and non faculty positions:

- c) Necessary action has already been taken to implement NPS.

Mentor Director explained the current situation of students, he also mentioned the food related problem in hostels, problems faced in finding safe accommodation for female students at one place in Kalyani.

Chairman instructed MHRD personnel to write a letter to CPWD to speed up their process of construction work.

Kalyani University Vice-Chancellor, member of Governing Body put forward the proposal to utilize the medical facilities of University of Kalyani on payment basis. Chairman also requested University of Kalyani Vice-Chancellor to examine the feasibility to accommodate the female students of IIIT Kalyani in the University Girls Hostel.

Item No. 3: To consider and approve the 1st Convocation of Indian Institute of Information Technology, Kalyani to be held on 23rd June, 2019

Resolution:
